(1) - Vacation Days vary based on number of years employed.

(2) - Longevity is a percentage of base salary (.5% at 5 yrs service, 1% at 10 yrs service, 1.5% at 10 yrs service and 2% at 20 yrs service)

(3) - Other Benefits includes, health, dental, life, and vision insurance and may include merit bonus if granted.

(4) - Actuarially determined amount required for employees. Employer contribution rate for IMRF is 10.70% and 105.95% for Police Pension.

IMRF employees contribute 4.5% and Sworn Police personnel contribute 9.91%.

(5) - Part-Time employees are paid on an hourly basis. Projected compensation is based on current work schedule; actual compensation may vary.

(6) - Employee salaries are based on merit with the exception of Police Officers whose salary is based on an approved step-plan.

Budgeted salary increases for merit based employees is not a guarantee of a salary increase. Total salary budgeted is \$1,635,747.

Some employees may receive a merit bonus. If given, merit bonuses are listed in Other Benefits.
