Pursuant to the Open Meetings Act (5 ILCS 120/7(e)), and because Village of Kenilworth meeting facilities are limited both in size and ability to reasonably accommodate social distancing, this open meeting of the ZBA will be held in a hybrid teleconference format. A quorum of the ZBA may not be physically present at Village Hall. Members of the public are welcome to attend via video, audio, or telephone and will have the opportunity to provide public comment during the Public Comment section of the agenda. Any public attendance or comment that violates the Village's public comment policy or in any way disrupts the ZBA meeting may be muted or blocked and the violator removed from the teleconference.
